



President's Letter

I'm proud to report that 2015 was a year of growth and accomplishments for CommonWealth Central Credit Union. Thanks to the loyalty of our membership and the combined efforts of our employees and volunteers, the credit union exceeded growth and financial performance targets in 2015. Loans to members increased by over \$30 million or 11%, member deposits increased by more than \$36 million or 9%, net income was \$2.7 million, and reserves remained strong at 9.4% of assets.

While financial performance is important, CommonWealth remains focused on service quality, convenience, and being easy to do business with. Service quality continues at a high level as measured and monitored through hundreds of member surveys each month. We continue to invest in employee training to ensure that members experience excellent service from knowledgeable employees. Members told us we are succeeding by voting CommonWealth the best financial institution in Milpitas and Morgan Hill in 2015.

We opened our second branch office in Morgan Hill in Cochrane Commons to expand convenient branch access to members in South Santa Clara County. This convenient new office features an innovative design and expanded self-service options for members. We upgraded our mobile banking system to improve convenience and ease of use for members and initiated a transition to in-house mortgage loan servicing to provide members with a more seamless mortgage experience. In addition, we initiated an effort to simplify and improve many internal processes within the credit union to ensure that we are "easy to do business with."

This past year was also a year of continued focus and involvement in the communities we serve. Credit union employees participated in many community events throughout the year, volunteering their time with organizations such as Turning Wheels for Kids, Rebuilding Together Silicon Valley, the Morgan Hill Fourth of July Parade and Second Harvest Food Bank, among many others.

As a locally-based, not-for-profit financial institution, we remain committed to serving you—our members—and the community through our products and services, our employees and our involvement.
